ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of TSRC.net, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is TSRC.net, Inc.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE


