

The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the law of the State of Florida.

ARTICLE I

NAME

The name of the corporation is VIOVIO FARM PICKING, INC.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the corporation's principal office is 905 N.E. 138th STREET, N. MIAMI, FLORIDA 33161 and the corporation's mailing address is the same.

DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence upon filing these Articles of Incorporation with the Department of State.

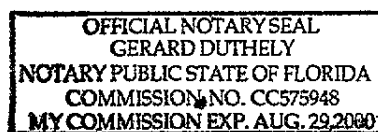
