The undersigned do hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of Flite Line Truck & Equipment Service Corporation.

1. The name of the Corporation is currently:

Flite Line Truck & Equipment Service Corporation.

2. The date of the filing of the Articles of Incorporation was December 3, 1999.

3. The Articles of Incorporation are amended as follows:

a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

The name of the corporation shall be "TESCO EQUIPMENT CORPORATION" (the "Company") and its principal place of business and mailing address shall be 3400 Burris Road, Fort Lauderdale, Florida, 33314 , County of Broward , State of Florida. The Company shall have the power and authority to establish branch offices at such place or places as may be designated by the officers and directors.

b. In all other respects, the Articles of Incorporation shall remain unchanged.

4. This Amendment was adopted by a written statement signed by the shareholders and the directors of Flite Line Truck & Equipment Service Corporation on March 21, 2000, pursuant to Section 607.1006 of the Florida Statutes.

5. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.

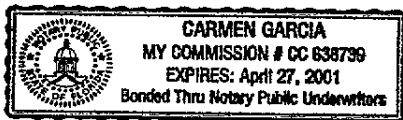
