ARTICLES OF INCORPORATION

I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

Winsook Development & Agricultural Corporation

The principal office and mailing address of this corporation shall be 701 N. Franklin Street, Tampa, FL 33602, or such other address within the State of Florida as the Board of Directors may from time to time designate.

ARTICLE II

Existence of Corporation
