### ARTICLES OF INCORPORATION

OF

### NOELLEN, INC.



#### ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be NOELLEN, INC., with its principal place of business at 4794 Southeast 115th Street, Belleview, Florida 34420.

#### ARTICLE II - NATURE OF BUSINESS
