The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I. NAME**

The name of this corporation is **H. D. PROPERTIES, INC.**

**ARTICLE II. DURATION**

The corporation shall exist perpetually, commencing on the date of the filing of these Articles.

**ARTICLE III. PRINCIPAL PLACE OF BUSINESS**
