## ARTICLES OF INCORPORATION OF

## CLADUTO RESTAURANT, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

## ARTICLE A Name and Address

Section a. The name of the Corporation shall be CLADUTO RESTAURANT, INC.

Section b. The address of the principal office of the Corporation is 880 Mandalay Ave., Clearwater Beach, FL 33767.

Section c. The mailing address of the Corporation is 880 Mandalay Ave., Clearwater Beach, FL 33767.

## ARTICLE B Purpose and Powers
