To whom it may concern:

This is to inform you of the unfortunate misplacement of the form for the Uniform Business Report for the Star Web Solutions, Corp., which has caused this report to be filed later than the due date of May 1, 2000.

Unfortunately, our office was affected by a fire in late March of 2000. The contractor, making preparations for fire restoration repairs, packed all salvageable contents of the office including the signed UBR form. We thought that the form had already been mailed, but now that we have unpacked following restoration work, the form was found.

It is our understanding that there is a \$400 penalty for late filing of the UBR form. However, since this late filing is due to circumstances beyond our control and considering the hardship caused by this unfortunate fire, we are requesting a waiver of the penalty. A check for the normal filing fee of \$150 is enclosed.

It is our hope and expectation that the Division of Corporations will respond positively to our request. This is a new business with its normal growing pains and now financial difficulties. Waiving of the penalty will be very helpful in allowing us to continue operating and contributing to the growth of the state's economy as well as to the employment of some of its residents.
