Articles of Incorporation Yates Edwards Consulting Services, Inc.

Article I. Name

The name of this corporation shall be:

Yates Edwards Consulting Services, Inc.

Article II. Nature of Business

The general nature of the business to be transacted is:

To engage in the business of consulting.

To do any and all other acts and things as are necessary or convenient to the attainment of the purposes of this corporation and any of them, to the same extent as natural persons lawfully might or could do in any part of the world, insofar as such acts are permitted to be done by a corporation organized under the laws of the state of Florida.

Article III. Principal Office

The amount of the capital with which this corporation will begin business shall not be less than one hundred dollars (\$100.00)

Article VI. Term of Existence

This corporation is to exist perpetually.

Article VII. Directors

There shall be one (1) director constituting the initial Board of Directors as follows:
