**ARTICLES OF INCORPORATION
OF

The undersigned, desiring to form a corporation (the "Corporation") under the laws of Florida, hereby adopts the following Articles of Incorporation effective December 3, 1999:

**ARTICLE I
CORPORATE NAME**

The name of the Corporation is Key Dominique, Inc.

In addition, the Corporation shall have the power, in its By-Laws or in any resolution of its stockholders or directors, to undertake to indemnify the officers and directors of this corporation against any contingency or peril as may be determined to be in the best interests of this corporation, and in conjunction therewith, to procure, at this corporation's expense, policies of insurance.






