ARTICLE II - DURATION

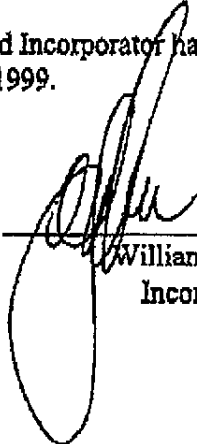

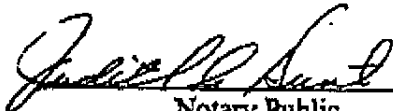

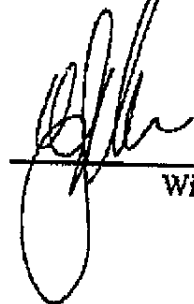
