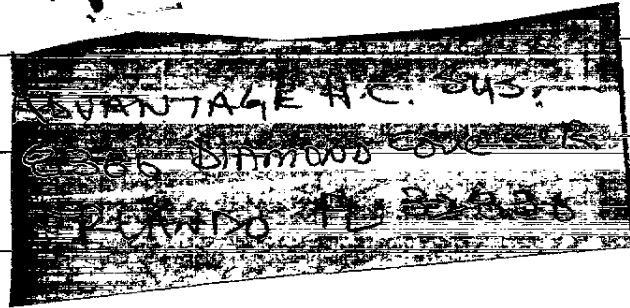

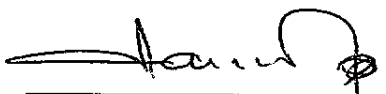

ARTICLES OF INCORPORATION
of

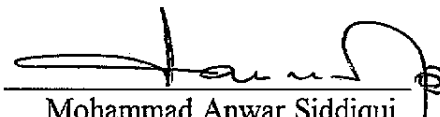

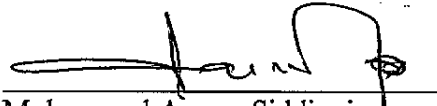
