ARTICLE ONE. NAME

The name of the corporation is JASON ENTERPRISES, INC.

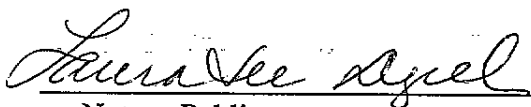

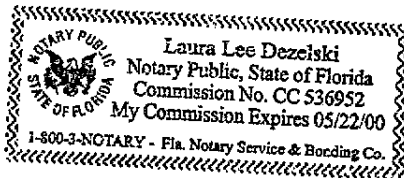

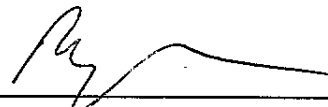
