ARTICLE I. NAME

The name of this corporation shall be Ideas of Palm Beach, Inc.

ARTICLE II. COMMENCEMENT & DURATION

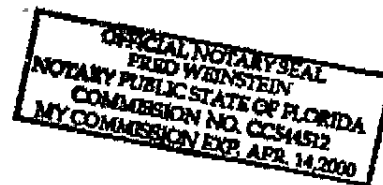
