ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this Corporation shall be as follows: FRANCISCO J. REY, M.D., P.A. The principal office and mailing address of the corporation shall be 11327 N.W. 58th Terrace, Miami, Florida 33178.

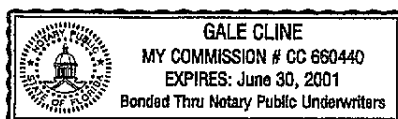
