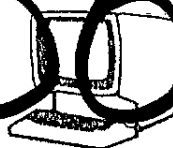

ARTICLES OF INCORPORATION
OF
ROBERTS DEE TRANSPORT, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation

ARTICLE I

CORPORATE NAME

The name of the corporation is: ROBERTS DEE TRANSPORT, INC.

ARTICLE II

INITIAL PRINCIPAL OFFICE

ARTICLE III

PURPOSE

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Corporation Act. The principal business activity shall be the operation of a Transportation operation.

ARTICLE IV

SHARES

The corporation shall issue 500 shares of stock at no par value.

ARTICLE V

DIRECTORS

The persons constituting the initial Board of Directors are Pauline Roberts, Glassford Roberts, Christeen Thames : After the initial Board of Directors, the Board

shall consist of such number of directors as shall be determined by the shareholders at their Annual Meeting at which time the Directors are appointed and/ or elected.

ARTICLE VI VOTING RIGHTS

All Stockholders can vote for the election of the officers of the corporation.

ARTICLE VII SPECIAL MEETINGS- CALL

Special meeting of the members may be called at any time, for any purpose by an officer of the corporation or by twenty (20%) percent of all members.

ARTICLE VIII MEMBERS RIGHTS & RESERVATION OF POWER TO ADOPT, AMEND, AND REPEAL BY-LAWS

The power to make, alter or amend and repeal the by-laws of the corporation shall be reserved to the Stockholders of the corporation.
