

Articles of Incorporation

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation.


1. The name of the corporation is G & G Transfer Service, Inc.
2. The address of the corporation is 740 8th Court, Vero Beach, Florida 32962.
3. The period of duration is perpetual.
4. The purpose is to move, transfer, relocate and process rental trucks to dealers and other locations, as designated by others, for reservation or maintenance purposes and to transport towing equipment or moving supplies, were needed and other activities or business permitted under the laws of the United States and Florida.
5. The corporation shall have authority to issue five hundred (500) shares of stock, all of one class, One Dollar (\$1.00) per share par value.


