ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
OGDEN, SULLIVAN & O'CONNOR, P.A.

Pursuant to Section 607.1006 of the Florida Business Corporation Act (the "Act"), the Articles of Incorporation of OGDEN, SULLIVAN & O'CONNOR, P.A., a Florida professional corporation (the "Corporation"), are hereby amended as follows:
