ARTICLES OF INCORPORATION

OF

PROFESSIONAL DUPLICATORS INTERNATIONAL, INC.

SECRETAL STATES

Article I - Name

The name of this corporation is: Professional Duplicators International, Inc.

Article II - Duration

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue One Hundred shares of One (\$1.00) Dollar par value common stock.
