**ARTICLE FIRST:** The name of the Corporation is Beach Area Properties, Inc.

**ARTICLE SECOND:** Article VII of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety, as follows:

**ARTICLE VII - BOARD OF DIRECTORS**

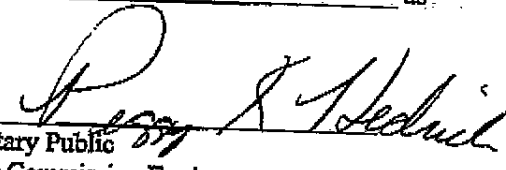

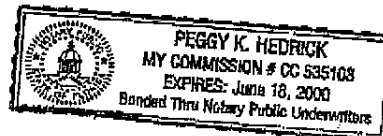
