ARTICLE 1- NAME

The name of this corporation is **LESTER T. COY, P.A.**

ARTICLE 11- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE 111- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as an attorney.

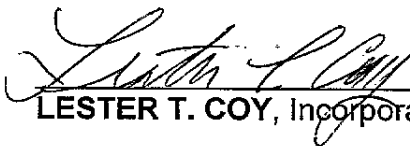
