ARTICLES OF INCORPORATION
OF

Article I

Name. The name of this Corporation is **EASYCALL WIRELESS OF GAINESVILLE, INC.**

Article II

Principal Office. The address of the principal office of the Corporation is 2632 NW 43rd Street, #A-104, Gainesville, FL 32606.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose.
