ARTICLES OF INCORPORATION  
OF

A 2 Z Mart Corporation

In compliance with the requirements of Chapter 607, Florida Statutes (1999), the undersigned, Syed Zamir Ahmad Gilani, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is

ARTICLE II

The existence of the Corporation shall begin on the date of the execution of these Articles of Incorporation by Syed Zamir Ahmad Gilani.

ARTICLE III

The street address of the principal office of the Corporation is 701 North Fort Harrison, Clearwater, Florida 33755.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is ten thousand, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V


