ARTICLES OF INCORPORATION

OF

Spring Training, Inc.

ARTICLE I - NAME

The name of this Corporation is Spring Training, Inc.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

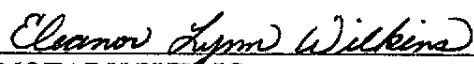

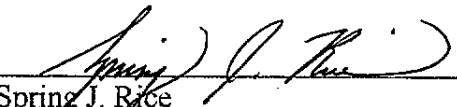
