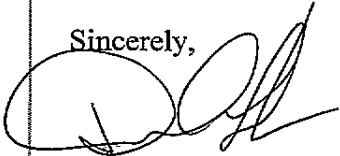

**SIXTH:** This corporation is to exist perpetually.

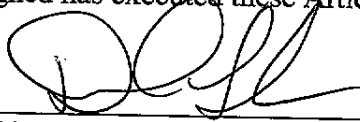
