The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address. The name and address of the Corporation is:

SALECHASER, INC. 6019 Margie Court, Orlando, Florida 32807

Article 2. Duration. The duration of the Corporation is perpetual.

<u>Article 3. Purpose</u>. The general purposes for which the Corporation is organized are the following internet services:

- a. to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way;
- b. to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them;
