

OF

ARTICLE ONE
CORPORATE NAME

The name of the professional corporation shall be:

AFFORDABLE TREEMEN, INC.

ARTICLE TWO
DURATION

The term of existence of the professional corporation is perpetual.

ARTICLE THREE
PURPOSE

The specific nature of the professional services to be rendered by this professional service corporation shall be:

1. 
