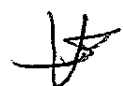

FIRST: Amendment (s) adopted:

ARTICLE FIRST. The name of the corporation is WEB2PHONE, INC.

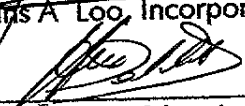
