ARTICLE I - NAME

The name of this corporation is BUNGALOW BEACHSIDE INVESTMENTS, INC.

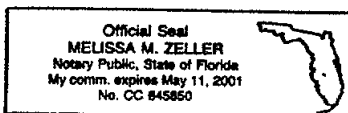




