

The undersigned, acting as Incorporator for the purpose of forming a for profit Corporation under the provisions of Chapter 607 of the Florida Statutes, hereby delivers the following Articles of Incorporation for said Corporation to the Department of State of the State of Florida.

**ARTICLE I: NAME**

The name of the Corporation is Rachel Smith Design, Inc. The address for the principal office of this corporation shall be 1105 Tangelo Isle, Fort Lauderdale, Florida 33315.

**ARTICLE II: PURPOSE**


