### ARTICLES OF INCORPORATION

OF

The undersigned Subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

### **ARTICLE I - NAME**

The name of this corporation is

Custom ARTISTIC Tile & Marble, INC.

### **ARTICLE II - DURATION**

The existence of this corporation is to begin at the time of subscription and acknowledgment of incorporation and to continue perpetually thereafter.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the primary purpose of owning, managing and operating a TILE \* MARBLE INSTALLATION \* REPAIR BUSINESS.

In addition, this corporation may engage in every phase of any and all activities or businesses permitted by the laws of the United States and of the State of Florida or any other state, territory, district or possession of the United States and all such activities or business as may be permitted in any foreign country.

## **ARTICLE IV - CAPITAL STOCK**
