

**ARTICLE I - NAME**

The name of this corporation is JACKSON MARKETPLACE, INC.  
and the principal office address is: 5830 NW 12 Avenue, Miami, FL 33127.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence unless sooner dissolved according to the law.

**ARTICLE III - PURPOSE**

This corporation is organized to engage in the business of owning and operating retail and wholesale distribution of food and general merchandise and providing related services such as lotto, check cashing, electronic payments, money orders, etc.; in conformity with the the existing laws, municipal rules and regulations or such as may be hereafter enacted; and to engage in any other lawful business from time to time.

#### **ARTICLE X - AMENDMENT**





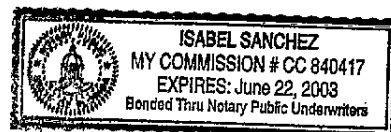
