**ARTICLE I
CORPORATE NAME**

The name of the corporation is **CANTECH, INC.** with its principal place of business at 7980 N. Atlantic Avenue, Cape Canaveral, FL 32920.

**ARTICLE II
CORPORATE NATURE**

This is a corporation for profit and may engage in any activity which is lawful under the laws of the State of Florida, including, but not limited to reprographic services.

**ARTICLE III
DURATION**

The term of existence of this corporation is perpetual.

**ARTICLE IV
CORPORATE OFFICERS**

Amendment to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote.

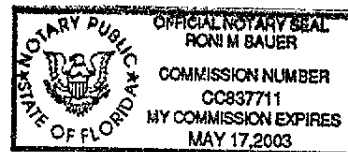
