ARTICLE I - NAME

The name of this corporation shall be E & E Drywall, Inc..

ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

ARTICLE III - CAPITAL STOCK
