ARTICLE 3. The principal place of business and mailing address of this corporation shall be 7326 Burnway Drive, Orlando, Florida 32819


ARTICLE 4. The corporation is authorized to have outstanding at any one time 100 shares of stock, at a par value of \$1.00 per share.
