INDEMNIFICATION

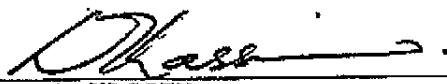
The Corporation shall indemnify any officer or Director or any former officer or director, to the full extent permitted by law.

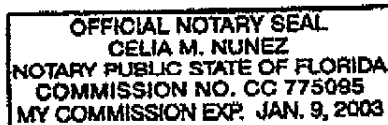

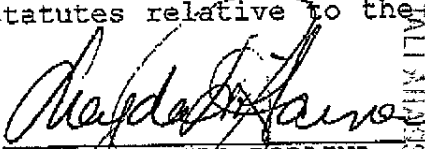
