ARTICLE 1. - NAME

The name of the corporation is **JOHN W. SWISHER, Ph. D., M.D., P.A.**

ARTICLE 2. - PRINCIPAL OFFICE


ARTICLE 10. - CUMULATIVE VOTING

ARTICLE 11. - INDEMNIFICATION



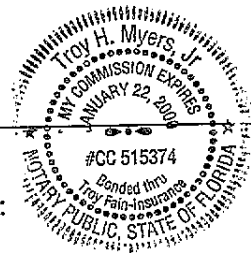
