SUNCOAST NAMVETS, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE: NAME

The name of the Corporation is SUNCOAST NAMVETS, INC. The principal address is 4632 Marine Parkway, New Port Richey, FL 34652.

ARTICLE TWO: TERM OF EXISTENCE

The duration of the Corporation is perpetual. Corporate existence is to commence on the date of filing of the Articles of Incorporation by the Secretary of State.

ARTICLE THREE: NATURE OF BUSINESS

The general purposes for which this Corporation is organized are. To transact and engage in any activity or business permitted under the laws of the United States and the State of Florida, except that it is not to conduct banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition. To do such other things as are necessary to or incidental to the foregoing or desirable in order to accomplish the foregoing.

ARTICLE FOUR: CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is Five Hundred (500), One Hundred (100) of which will be issued at this time as follows: Fifty (50) Shares to HARVEY A. WARSHAWSKY and LORRAINE WARSHAWSKY, as joint tenants with right of survivorship; and Fifty (50) Shares to EDWARD J. WARD. Said shares shall be of a single class and have a par value of Five Dollars (\$5.00) per share.

ARTICLE FIVE: INITIAL CAPITAL

The amount of capital with which the Corporation will begin business is Five Hundred Dollars (\$500.00). Capital contributions shall be in cash or other equivalent property, but shall not include services.

<u> ARTICLE SIX: ADDRESS</u>

The street address for the initial registered office of the Corporation is 4632 Marine Parkway, New Port Richey, FL 34652. The board of directors may from time to time move the principal office to any other address in Florida.

ARTICLE SEVEN: INITIAL DIRECTORS

The number of Directors constituting the initial board of Directors of the Corporation is Two (2). The number of Directors may be increased or diminished from time to time by BYLAWS adopted by the Stockholders, but shall never be less than One (1).

Every amendment shall be approved by the Board of Directors proposed by them to the Stockholders, and approved at a Stockholder's meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the Stockholders sign a written statement manifesting their intention that certain amendments of these Articles of Incorporation be made.
