ARTICLES OF INCORPORATION
OF

Article I - Name and Address

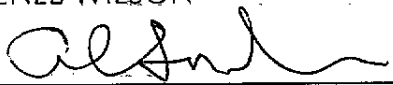

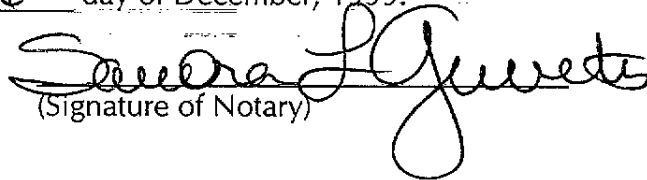

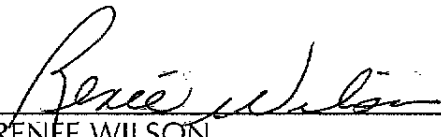
