This letter is to request that the Tesco Supply, Inc. may be allowed to pay standard Licensing fees for the year 2000 and the common renewal fee for 2001. This request is submitted under the acknowledgment of the State of Florida's policy to pardon late payment of required fees when due to undelivered mail. The mailing address on file for Tesco Supply, Inc. was missing the Unit number, the lack of which resulted in no mail from the State being received by the officer of the company.

The payment of licensing fees was completed in December 1999 with the misconception that the year 2000 was in good standing. Any notification of this error sent to the business was undelivered. When the company applied to renew the 2001 license, our representative was informed that because of the lapse in payment for 2000, a \$600.00 fine would be imposed, and the company would have to reapply for a business license.

However during the years 2000 and 2001, Tesco Supply, Inc. did not operate in Florida with out a valid license. In light of the fact that Tesco Supply, Inc. did not
