# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BLACKSTONE CORPORATION

Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is BLACKSTONE CORPORATION
- 2. The following Amendment of the Articles of Incorporation was adopted by the Shareholders of the Corporation on the 14 day of May, 2007, in the manner prescribed by Florida law.

Article VIII of the corporate charter filed on December 8, 1999, is amended as follows:

#### "ARTICLE VIII Capital Stock

The Corporation is authorized to issue ONE HUNDRED (100) shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock which shall be designated "Class A Voting Common Shares"; and ONE HUNDRED (100) shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock which shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock."

- 3. The number of shares of the Corporation outstanding at the adoption was six hundred (600), and the number of shares entitled to vote thereon was six hundred (600).
- 4. The number of shares voted in favor of such Amendment was six hundred (600), and the number of shares voted against such Amendment was none.
- 5. This Amendment shall become effective immediately upon filing with the Department of State of Florida.
