THIS IS TO CERTIFY that we, the undersigned, for the purpose of forming a corporation under the provisions of Florida Statutes 1997, Chapter 607, and statutes amendatory thereof and supplementary thereto, do hereby make, subscribe, acknowledge and file these Articles of Incorporation, and we do certify that:

1. The name of the corporation is:

FLORIDA TROPICAL LIMITED, INC.

2. The major purpose of the corporation will be to engage in the business of owning and operating commercial property for lease to the general public. In addition, the general nature of the business transacted shall be:
