**ARTICLE I  
NAME**

The name of the Corporation and the address of the principal office of this Corporation is

**ARTICLE II  
CAPITAL STOCK**

The aggregate number of shares which this Corporation shall have authority to issue is 1,000 shares of common stock. Common shares shall be the only class of shares which this Corporation shall have authority to issue. Such shares shall be treated as stock under Section 1244 of the Internal Revenue Code in the event of loss upon the sale or exchange of these shares. Any such loss shall be deemed an ordinary loss, to the extent allowed by Section 1244.

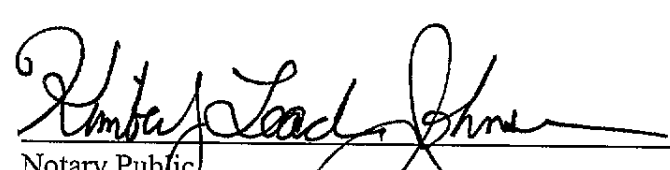

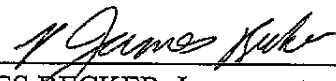
