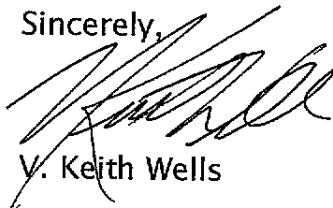

The undersigned, acting as incorporators for a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: CLEANER Process Technologies, Inc.

ARTICLE II. NATURE OF BUSINESS

The purpose of this corporation shall be unlimited as to engage in any lawful activities as are generally connected with the course and purpose of profit-making.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares, each with a par value of One Dollar (\$1.00); the initial issue will be 500 shares of stock. The corporation may increase the number of authorized stock from time to time as may be necessary.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business is the sum of Five Hundred (\$500.00) dollars.

ARTICLE V. TERM OF EXISTENCE

This corporation shall exist perpetually and upon the filing of these Articles of Incorporation with and acceptance by the Secretary of State of the State of Florida.

ARTICLE VI. ADDRESS

The street address for the initial office of the corporation in the State of Florida is 1431 Glenmore Drive, Cantonment, Florida 32533. The Board of Directors may from time to time move the said office to any other address in Florida.

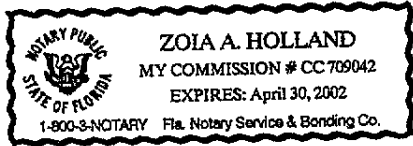
