**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

Article I - Name

The name of this corporation is **CAPRICORN MOON PUBLISHING, INC.**

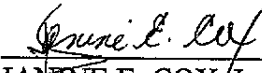
Article X - Amendment

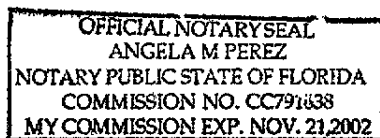

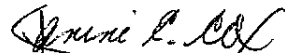
