THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is Lewis Trading Inc.

The duration of the corporation is perpetual.

The general purposes for which the corporation is organized are:

1. To engage in investing and securities trading.
