The undersigned, for purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is IXORA CORP

ARTICLE TWO

ARTICLE THREE

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is December 02, 1999 at 5:00 PM

The general purposes for which the corporation is organized are:

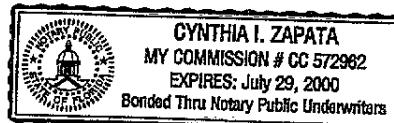
