ARTICLE I:

The name of the Corporation is: **ROBERT HUGULEY ENTERPRISES, INC..**

ARTICLE IX - AMENDMENT



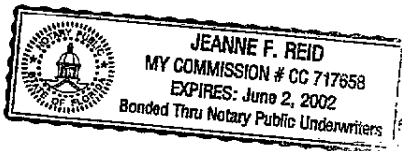
