# ARTICLES OF INCORPORATION OF HAWKEYE CHARTERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### ARTICLE I NAME

The name of the corporation shall be HAWKEYE CHARTERS, INC.

## ARTICLE II PRINCIPAL OFFICE

The street address of the principal office is 5127 Genesee Parkway, Bokeelia, Florida 33922, and mailing address of this corporation shall be P.O. Box 91, Matlacha, Florida 33993.

## ARTICLE III CAPITAL STOCK

No such proposed transfer shall be made until the aforesaid sixty (60) days have expired or the Board of Directors have
