ARTICLE 1: NAME AND ADDRESS

The name of this Corporation is: West Pasco Lawyer's Referral Service, Inc. , and the address is: 7529 Redcoat Ave., Port Richey, FL 34668.

ARTICLE 2: DURATION

This Corporation shall exist perpetually. In accordance with Section 607.0203, the date when existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE 3: PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business and more specifically to:

1. make legal services readily available to the general public;
2. provide information about lawyers and the availability of legal services which will aid in the selection of a lawyer;
3. inform the public when and where to seek legal services and to provide an initial determination of whether such services are necessary or advisable;
4. provide legal and general information as well as a referral to consumer, government and other agencies when such is in the best interest of the individual concerned;
5. engage in any other lawful pursuit that can better serve the public in their understanding of legal processes.

ARTICLE 4: CAPITAL STOCK

This Corporation is authorized to issue 7500 shares of \$1.00 par value common stock.

ARTICLE 5: INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 6645 Ridge Road, Port Richey, Florida 34668, and the name of the initial registered agent of this Corporation at that address is Alfred W. Torrence, Jr..

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

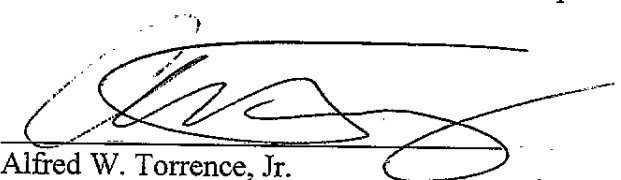
ARTICLE 9: BYLAWS

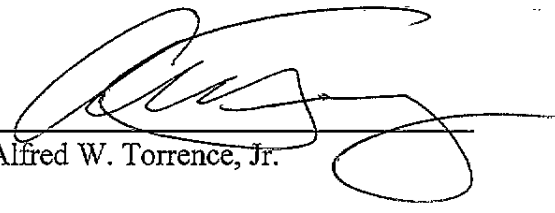
